## 04/15/2024

**Fraud**  
**9455 W Loomis Rd**

On Monday, 04/15/24, a resident reported being swindled out of \$202 by a subject he met on a dating website who alleged to be a police officer from Tel Aviv. "She" requested funds to help her evacuate Israel. He reported discovering the scam after he attempted to cash a check sent to him by the actor for \$35,000 which was determined by his bank to be fraudulent.

On Monday, 04/15/24, a subject reported being defrauded out of \$1,300 via Venmo for a golf trip to Pebble Beach which never occurred.
