01/01/2024

Warrant Arrest 2600 Blk W College Ave

On Monday, 01/01/24, at 0207 hours, a subject was taken into custody for having a felony warrant with the WI Department of Corrections for Parole Violations/Larceny. This occurred pursuant to a traffic stop. He was later turned over to the Milwaukee Secure Detention Facility.

Retail Theft, Disorderly Conduct, Possession of Drug Paraphernalia

Disorderly Conduct, Battery
8253 S 27th St - Embassy Motel

Battery, Strangulation – Domestic Violence Related, Disorderly Conduct

Disorderly Conduct – Domestic Violence Related, Recklessly Endangering Safety, Resisting Arrest
3700 Blk W Thorncrest Dr

On Monday, 01/08/24, at 0157 hours, a subject out of Pennsylvania was taken into custody for Disorderly Conduct – Domestic Violence Related, Failure to Comply with Officers, and 2nd Degree Recklessly Endangering Safety. This occurred on Sunday, 01/07/24, at 2159 hours, after he and his fiancé were involved in an altercation during which the brandished a firearm. He then barricaded himself in his vehicle in the driveway of the residence. Swat teams from Franklin, Hales Corners and Greendale were utilized as well as a negotiator from Oak Creek PD and the suspect was taken into custody without further incident. He was transported to County Jail with charges referred to the District Attorney's office.
