### Resident Sex Offender Notification

The Franklin Police Department in cooperation with the Sex Offender Registration Committee, is releasing the following information pursuant to Wisconsin State Statutes 301.46(2m) which authorizes law enforcement agencies to inform the public of a sex offender's release, when, in the discretion of the agency, the release of information will enhance public safety, awareness and protection. The individual who appears on this notification has been or has committed an offense that requires registration with the Wisconsin Department of Corrections. Further, previous criminal history places him/her in a classification level which reflects the potential to re-offend. **Note: Information regarding offenders under the age of 18 cannot be disseminated beyond law enforcement officials.**

The sex offender has served the period of incarceration imposed on him by the courts. The offender, under the supervision of the Department of Corrections, Division of Community Corrections, will be living at the location listed below. **He is not wanted by the police at this time. This notification is not intended to increase fear, rather, it is our belief that an informed public is a safer public.**

**\*\*\*Citizen abuse of this information to threaten, intimidate or harass registered sex offenders will not be tolerated and violators will be arrested and prosecuted. Please understand that such abuse could potentially end law enforcement's ability to make these community notifications. We believe the only person who wins if community notification ends is the sex offender, since sex offenders derive their power or ability to victimize through secrecy.**
