The Franklin Police Department in cooperation with the Sex Offender Registration Committee, is releasing the following information pursuant to Wisconsin State Statutes 301.46(2m) which authorizes law enforcement agencies to inform the public of a sex offender's release, when, in the discretion of the agency, the release of information will enhance public safety, awareness and protection. The individual who appears on this notification has been or has committed an offense that requires registration with the Wisconsin Department of Corrections. Further, previous criminal history places him/her in a classification level which reflects the potential to re-offend. **Note: Information regarding offenders under the age of 18 cannot be disseminated beyond law enforcement officials.**

The sex offender has served the period of incarceration imposed on him by the courts. The offender, under the supervision of the Department of Corrections, Division of Community Corrections, will be living at the location listed below. *He is not wanted by the police at this time. This notification is not intended to increase fear, rather, it is our belief that an informed public is a safer public.*

INCIDENT SUMMARY

Patrick Schulz's conviction resulted from an incident which occurred in 2005 in Milwaukee, Wisconsin, in which he used a computer to communicate over the Internet with a person who had not attained the age of 16 years intending to have sexual relations. Schulz agreed to meet the juvenile female to have sexual relations and was arrested by a police officer posing as the juvenile.
