Copies of the aforesaid maps, plans and financial information for the future development areas are available and open for inspection by the public in the office of the City Clerk at Franklin City Hall, 9229 West Loomis Road, Franklin, Wisconsin 53132, during normal business hours. The public is invited to attend the public informational meeting and to provide input.
