- A. Commissioner Fowler moved and Commissioner Bennett seconded approval of the July 21, 2011 minutes of the regular meeting of the Plan Commission as presented. On roll call, all voted 'aye'. Motion carried.

- A. Senior Planner Fuchs gave an introduction and background on the application by U-Haul Co. of Wisconsin, Inc. for a Unified Development Ordinance text amendment at Table 15-3.0603.

Commissioner Ritter moved and Commissioner Fowler seconded a motion to recommend denial of an ordinance to amend the Unified Development Ordinance text at Table 15-3.0603 Standard Industrial Classification Title No. 7513 "Truck Rental and Leasing, No Drivers", to allow for such use as a Special Use in the B-4 South 27th Street Mixed-Use Commercial District. On voice vote, Commissioners Ritter, Fowler, Michlig and Bennett, and Alderman Skowronski voted 'aye'. Motion carried.

B. Senior Planner Fuchs gave an introduction on the request by The Crown Group, Inc. to divide the parcel located at 7199 South 76th Street into two lots with zero foot lot line building and parking setbacks within Planned Development District No. 16 (Franklin Centre).

Commissioner Ritter moved to suspend the regular order of business to allow Alderman Solomon to speak. Seconded by Commissioner Fowler. All voted 'aye', motion carried.

Commissioner Ritter moved and Commissioner Bennett seconded to return to regular order of business. All voted 'aye', motion carried.
