IV. Recommendation on Landfill Siting Revenue Allocation to Funds for Budget Year 2018

Director of Finance & Treasurer Paul Rotzenberg presented and reviewed this item with the Committee. Discussion was held.

Motion made by Member Howard and seconded by Alderman Dandrea to recommend that the Common Council direct the Director of Finance to bring forward an Anticipation Note Borrowing Resolution for a maximum of \$36 Million, with the sale to be completed prior to December 31, 2017. Upon vote, Ayes-All, motion carried.
