- A. Commissioner Ritter moved and Commissioner Bennett seconded approval of the February 3, 2011 minutes of the regular meeting of the Plan Commission as presented. On roll call, all voted 'aye'. Motion carried.
- A. After an introduction by Planning Manager Dietl, City Engineer Bennett presented the Ryan Creek Interceptor Sewer Extension project to the Plan Commission.

Alderman Skowronski moved and Commissioner Ritter seconded a motion to approve the Ryan Creek Interceptor Sewer extension and location as presented to the Plan Commission on February 17, 2011, subject to such minor revisions determined to be reasonably necessary by the City Engineer to further the overall project, and to recommend approval of a determination of necessity of public acquisition of easements for the Ryan Creek Interceptor Sewer installation upon real property in the area from the intersection of South 60th Street and West Ryan Road generally following the Ryan Creek to the intersection of West Ryan Road and South 112th Street, thence westerly along West Ryan Road to the west City limits. All voted 'aye', motion carried.

B. Planning Manager Dietl presented the application to determine whether a proposed amendment to change the boundary of Planned Development District No. 31 (Foresthill Highlands/United Financial Group, Inc.) (Senior Living Community) where it abuts an individual residential lot, at the Northeast corner of the district off West Forest Hill Avenue, to move the lot line of the residential lot 60 feet west is a minor amendment or a substantial alteration to the plan.

Alderman Skowronski made a motion to determine the proposed amendment to be a minor amendment. Seconded by Commissioner Ritter. All voted 'aye', motion carried. lot at the Northeast corner of the district off West Forest Hill Avenue to move the lot line of the residential lot 60 feet west, is a minor amendment or a substantial alteration to the plan.
