Seconded by Member Haley. On voice vote, all voted 'aye'. Motion carried.

E. Alderman Wilhelm made a motion to amend Article VIII., Section 1 of the Administrative Rules and Procedures of the Franklin Complete Streets and Connectivity Committee at line one to read "The regular monthly meeting of the Committee will be held on the Thursday following the regular Common Council meeting date of the first Tuesday of each month, or at the call of the Chair". Seconded by Member Haley. On voice vote, all voted 'aye'. Motion carried.

F. Senior Planner Fuchs presented recent changes and updates to the development and location project for the Pleasant View/Victory Creek Trail.

Member Haley moved to support the most recent Plan Commission and Common Council recommendations for the development and location of the Pleasant View/Victory Creek Trail. Motion seconded by Member Reed. All voted 'aye', motion carried.

- G. No action needed, none taken regarding the Resolution Setting Forth the City of Franklin's Support of a Complete Streets Policy.
- H. Discussion only regarding proposed roadway improvements for South 68th Street/County Trunk Highway A, and South North Cape Road/Country Trunk Highway J as outlined in the letter dated March 20, 2013 from the Milwaukee County Department of Transportation. No action needed, none taken.

Discussion and review of the Preliminary Plat for the proposed Avian Estates Subdivision development. Justin Johnson, PE, McClure Engineering Associates Inc., spoke on behalf of the applicant and indicated the possibility of placing the 20-foot Emergency and Pedestrian Access Easement in an outlot, opposed to an easement located on Lots 6 and 7.
