

**CITY OF FRANKLIN
COMMON COUNCIL MEETING
JUNE 15, 2010
MINUTES**

- ROLL CALL A. The regular meeting of the Common Council was held on June 15, 2010 and called to order at 6:30 p.m. by Mayor Taylor in the Franklin City Hall Council Chambers, 9229 W. Loomis Road, Franklin, Wisconsin. On roll call, the following were in attendance: Aldermen Olson, Solomon, Wilhelm, Taylor, Schmidt and Skowronski. Also present were Director of Administration Luberda, City Attorney Wesolowski and City Clerk Wesolowski.
- CITIZEN COMMENT B-1. Citizen comment period was opened at 6:30 p.m. and closed at 6:36 p.m.
- MINUTES-06/01/2010 C-1. Alderman Olson moved to approve minutes of the regular meeting of June 1, 2010 as presented. Seconded by Alderman Solomon. All voted Aye; motion carried.
- PUBLIC HEARING-IDRB (DASH MEDICAL GLOVES, INC. PROJECT) D-1. A public hearing regarding the proposed sale and issuance of not to exceed \$2,500,000 Industrial Development Revenue Bonds, Series 2010 (Dash Medical Gloves, Inc. Project) was opened at 6:40 p.m. and closed at 6:41 p.m. (See Item G-1.)
- RES. 2010-6648 IDRB (DASH MEDICAL GLOVES, INC. PROJECT) G-1. - At 7:15 p.m. Mayor Taylor passed the gavel to Council President Taylor, who then chaired the meeting. At 7:20 p.m. the gavel was returned to Mayor Taylor, who then returned to chairing the meeting.
- Alderman Wilhelm moved to return to the regular order of business. Seconded by Alderman Olson. All voted Aye; motion carried.
- Alderman Wilhelm moved to select Alternative B for the reconstruction of S. 76th Street from W. Terrace Drive to W. Puetz Road. Seconded by Alderman Taylor. On roll call, Aldermen Solomon, Wilhelm, Taylor, Schmidt, and Skowronski voted Aye; Alderman Olson voted No. Motion carried.

Alderman Olson moved to schedule a public hearing and consideration of grant applications for the July 13, 2010 Common Council meeting for the 2011 Milwaukee County Community Development Block Grant Program. Seconded by Alderman Schmidt. All voted Aye; motion carried.

Alderman Solomon moved to adopt Resolution No. 2010-6649, A RESOLUTION TO AMEND RESOLUTION NO. 2006-6207 IMPOSING CONDITIONS AND RESTRICTIONS FOR THE APPROVAL OF A SPECIAL USE FOR COLLOCATED WIRELESS ANTENNAS AND GROUND BASED EQUIPMENT CABINET FOR PROPERTY LOCATED AT 5510 WEST RAWSON AVENUE (CLEAR WIRELESS LLC, APPLICANT). Seconded by Alderman Taylor. All voted Aye; motion carried.

Alderman Olson moved to approve the Plan Commission recommendation regarding the Republic of Croatia flag, to be installed by the Federation of Croatian Societies, Inc. as part of the Site Plan Amendment for entry gate improvements (at 9140 South 76th Street), as exempted from §210-3., Signs and Billboards “Permits and fees,” in accordance with §210-6.K., “Exemptions from permit regulations” with the condition that the American Flag be placed one foot higher. Seconded by Alderman Taylor. All voted Aye; motion carried.
- UPGRADE GCS SOFTWARE FOR PROPERTY TAX ASSESSMENT AND TAX COLLECTION G-6. Alderman Taylor moved to approve upgrading the GCS software to the SQL version and add a web portal for inquiry into the property tax database at an additional cost of \$5,000 funded from the fund balance in the Capital Outlay Fund. Seconded by Alderman Skowronski. On roll call, Aldermen Skowronski, Taylor, and Solomon voted Aye; Aldermen Schmidt, Wilhelm, and Olson voted No. Mayor Taylor broke the tie by voting in the affirmative. Motion carried.
- Alderman Solomon moved to table to the July 13, 2010, Common Council meeting, the display of property owners’ names in the property tax web portal. Seconded by Alderman Taylor. All voted Aye; motion carried.
- RUEKERT-MIELKE RYAN CREEK INTERCEPTOR ADDITIONAL PAYMENT G-7. Alderman Solomon moved to authorize the payment of the additional services by Ruckert-Mielke for the additional services associated with the Ryan Creek Interceptor Advanced Facilities Plan Amendment in the amount of \$18,597.94. Seconded by Alderman Schmidt.

Alderman Skowronski moved to call the question. On roll call, Aldermen Solomon, Schmidt, and Skowronski voted Aye; Aldermen Olson, Wilhelm, and Taylor voted No. Motion failed due to lack of majority vote.

On roll call, Aldermen Olson, Wilhelm, and Schmidt voted Aye; Aldermen Solomon, Taylor, and Skowronski voted No. Motion failed due to the lack of a majority vote.

Alderman Taylor then moved to proceed with Alternate 2 (rural section \$1,500,000 and local 20% \$300,000) for the rough cost for the reconstruction of W. Puetz Road from S. 76th Street to W. St. Martins Road under the Surface Transportation Program (STP). Seconded by Alderman Solomon. On roll call, Aldermen Skowronski, Taylor, and Solomon voted Aye; Aldermen Schmidt, Wilhelm, and Olson voted No. Mayor Taylor broke the tie by voting in the affirmative. Motion carried.
