A copy of the press release was distributed for review. Locally, pool operators provide a daily log of the pool chemical levels and water quality observation reports to the Franklin Registered Sanitarian for review. On-site inspections occur 3-4 times per year by the City Sanitarian.

A copy of the proposed bill was distributed for review. Governor Scott Walker has signaled that he would approve legislation if safeguards are in place.

The BOH have concerns with raw milk due to a lack of vitamin D, its high fat content, possible bacterial infections (E. coli, Salmonella, or Listeria) from unpasteurized milk and dairy products.

The BOH directed the Health Office to draft a letter for the next BOH meeting to our legislators stating these possible problems along with other positions on raw milk. They include that no other dairy products other than milk are sold, that farmers not sell their milk to third party producers or wholesalers; the farmer test the milk monthly for pathogens; the farmer take daily samples and freeze them for later inspection if necessary; the farmer would keep track of who made the purchase and date of purchase; and that there would be a stronger warning on the label, especially for high risk population. It should also be clarified that "raw milk" refers only to cow's milk.

A copy of the WF-Franklin Hospital CHIP and background information was distributed for review and discussion. The BOH encouraged the Health officer to seek mutual opportunities to coordinate and cooperate with Wheaton Franciscan as they implement their plan.

A copy of the flu season count was distributed for review. The FHD has given 1,625 influenza vaccinations this season.
