SCADA UPGRADE

City's SCADA system is over 20 years old and in need of replacement. The estimated cost for a new system is \$190,000 with a 60/40 split with the Sewer Department. Staff recommends proceeding with the replacement of the SCADA System. Board was in agreement.

PROGRAMABLE LOGIC CONTROLLER (PLC) FIBER OPTIC CABLING A motion by Commissioner Graef, seconded by Commissioner Peterson for staff to proceed with the installation of the fiber optic cabling from the Puetz Road Pumping Station to the Puetz Road Water Tower at a cost of \$4,340.00. Motion carried.

STATUS OF DREXEL AVENUE WATER TOWER

The interior painting of the water tower is near completion. Weather permitting the sandblasting on the outside has begun.

Staff asked the Board to review the design of the City's logo that will be included in the final painting on the water tower.
