All Final Plat submittals must include and be accompanied by the following:

- This Application form accurately completed with original signatures (facsimiles and copies will not be accepted).
- Application Filing Fee: \$1,000, payable to the City of Franklin.
- Milwaukee County Review Fee: \$100, payable to Milwaukee County Register of Deeds (for Condo Plats only).
- WI DOA "Request for Land Subdivision Plat Review" form and fee payment, as applicable.
- An electronic copy of the Legal Description for the subject property.
- Sixteen copies of a Project Narrative (i.e., a detailed description of the project).
- Sixteen 24 x 36 inch copies of the Final Plat or Condominium Plat. All plans must be collated and folded into 9 x 12 inch sets. See Division 15-7.0600 of the UDO* for information that must be denoted on each respective plan or included with the submittal and Division 15-9.0300 for Final Plat review and approval procedures.
- For Condominium Plats: One copy of the applicable Site Intensity and Capacity Calculations, if applicable. (See Division 15-3.0500 of the UDO).
- For Condominium Plats: Sixteen 24 x 36 inch colored copies of the Natural Resource Protection Plan (NRPP), collated and folded into 9 x 12 inch sets, and three copies of the NRPP report, if applicable. See Sections 15-4.0102 and 15-7.0201 of the UDO for information that must be denoted on or included with the NRPP.

- A meeting must be scheduled with the Planning Department prior to Application submittal.
- Upon receipt of a complete submittal, staff review will be conducted within ten business days.
- All Final Plats shall comply with Chapter 236 of the Wisconsin State Statutes.
- All Final Plat requests require Common Council Approval.

The applicant and property owner(s) hereby certify that: (1) all statements and other information submitted as part of this application are true and correct to the best of applicant's and property owner(s)' knowledge; (2) the applicant and property owner(s) has/have read and understand all information in this application; and (3) the applicant and property owner(s) agree that any approvals based on representations made by them in this Application and its submittal, and any subsequently issued building permits or other type of permits, may be revoked without notice if there is a breach of such representation(s) or any condition(s) of approval. By execution of this application, the property owner(s) authorize the City of Franklin and/or its agents to enter upon the subject property(ies) between the hours of 7:00 a.m. and 7:00 p.m. daily for the purpose of inspection while the application is under review. The property owner(s) grant this authorization even if the property has been posted against trespassing pursuant to Wis. Stat. §943.13.
