

Warrant Arrest S 27th St/W College Ave

On Monday, 02/05/24, at 1936 hours, a subject was taken into custody on a warrant with the Greenfield Police Department for an unpaid citation. This occurred pursuant to a traffic stop. He was released after signing a Personal Recognizance bond and receiving a new court date.

On Tuesday, 02/06/24, two residents reported receiving threatening messages from their estranged son. This was done in violation of a no-contact order. Charges were referred to the District Attorney's office.

Prowling, Liquor Law Violation 7973 S 100th St – Silent Night Motel

On Tuesday, 02/06/24, at 2152 hours, two subjects out of Oak Creek were taken into custody for Prowling and Underage Possession of Alcohol. A subject got into the vehicle and fled from Officers, leading them on a 4.5 mile pursuit which was terminated on I-94 due to speed and danger to the public. The subject abandoned the vehicle at a business in Oak Creek but was located by Oak Creek PD and taken into custody. The subject was linked to the recent cell phone thefts at area businesses. He was booked, and transported to County Jail. Charges were referred to the District Attorney's office for review.

Trespass to Property 2818 W Rawson Ave - Anytime Fitness

On Wednesday, 02/07/24, Officers were called to Anytime Fitness by the manager who reported a subject trespassing in the gym. This subject had been advised by staff in the past not to return. Officers escorted him off the property.

Through investigation, it was determined that an individual, who fled prior to Officer arrival, had stabbed the caller and struck him with a vehicle. The case was referred to the District Attorney's office for further review. The caller was cited after it was learned he falsified many details of the event.
