RECOMMENDATIONS

BACKGROUND

John's Disposal Services, Inc. provides garbage and recycling pickup services for the City of Franklin. Per the contract, recycling is picked up every other week with automated totes and garbage is picked up every week in customer-provided containers not to exceed 40 gallons or 80 pounds. Many Franklin residents routinely have overflowing recycling containers and use garbage containers that exceed 40 gallons and/or dispose of over 80 pounds of garbage per container.

AUTOMATED GARBAGE SERVICES

Revisions to the contract were discussed by Common Council in September and at the time, no changes beyond the CPI increase were considered in the 2020 budget.

ANALYSIS

John's will provide an updated proposal at the meeting. Staff has summarized the options with the attached spreadsheet.

Any changes will require a contract amendment with the new rates and a waiver of the CPI annual increases.

John's anticipates having a representative at the Common Council meeting to deliver and discuss the revised proposal and answer any questions.
