Stantec Consulting Services Inc. (Stantec) is pleased to present the City of Franklin this letter summarizing the blast monitoring performed in the vicinity of the Payne & Dolan (P&D) Franklin Aggregates quarry in Franklin, WI for the period August 1-31, 2019. Stantec is providing remote vibration monitoring by using two seismographs (deployed by Sauls Seismic), each co-located with existing P&D monitors (deployed by Vibra-Tech) at 7301 S. 51st Street and 5800 W. Allwood Drive. P&D also has two additional monitors located at 7526 S. 51st Street and SE of Quarry. Both the Stantec and P&D seismographs are configured to provide continuous (24/7) remote monitoring.

Stantec has prepared the attached tables summarizing and comparing data from the P&D and Stantec monitor recordings. This letter provides highlights of the data collected during this period.

### **General Notes**

- The monitoring period was completed between August 1 (12:00 AM) and August 31 (11:59 PM), 2019, which is net 31-day monitoring period.
- During this period P&D had a total of 20 blasting events (Shot ID's 96-115). The Stantec monitors confirmed 18 of the 20 blasting events (90%).
- At the monitors located at 5800 W. Allwood Dr., P&D confirmed no blasts (0%) while Stantec also confirmed none (0%). At the monitors located at 7301 S. 51<sup>st</sup> St. P&D confirmed 20 blasts (100%) while Stantec confirmed 18 (90%).

<u>Comments:</u> All blasts were completed in the east-central portion of the quarry; none were completed in the far southern region.

### PPV comparison – monitor values

- 15 Number of P&D maximum value PPV values greater than Stantec monitor
- 5 Number of Stantec maximum value PPV values greater than P&D monitor
- 0 Number of P&D maximum value PPV values equal to Stantec monitor
- The recorded PPV measurements by P&D and Stantec did not exceed the permissible limit as outlined in the current Planned District Development (PDD) agreement.

<u>Comments</u>: Although the monitors have slightly different resulting measurements for the same blasts, the P&D monitors appear to be more conservative (e.g., higher values).

<u>Comments</u>: A geographic review of the blast locations indicated all blasts were completed in the east-central portion of the active quarry, adjacent the monitors along S. 51<sup>st</sup>. Street. None of the blasts were completed in the southern portion of the active quarry, adjacent to the monitors on W. Allwood Drive. Thus, it makes sense that the monitors on S. 51<sup>st</sup> St. recorded the highest PPV values.
