CITY OF FRANKLIN PARKS COMMISSION REGULAR MEETING AND PARKS TOUR MINUTES February 14, 2022

CALL TO ORDER I. Chair Michael Wrench called the February 14, 2022 Parks Commission regular meeting to order at 6:33 p.m. in the Hearing Room at Franklin City Hall located at 9229 W. Loomis Road, Franklin, Wisconsin. Present were Chair Michael Wrench, Vice Chair David Bartels, Alderwoman Shari Hanneman, Commissioners Mary Remington, Karen Malecki and Janice Coenen. Excused was Ex-Officio member Michelle Runte. Also present were Department of Public Works Kevin Schlueter and Dale Borchardt, City Engineer Glen Morrow and Associate Planner Marion Ecks. **CITIZEN COMMENT PERIOD** II. The citizen comment period opened at 6:35 p.m. and closed at 6:35 p.m.. No citizen was present. **APPROVAL OF MINUTES** Commissioner Remington moved and Alderwoman Ш. – Regular meeting minutes of January Hanneman seconded to approve the minutes of the 10, 2022. regular Parks Commission held January 10, 2022. On voice vote, all voted 'aye'. Motion carried (6-0-0).

NEW BUSINESS:

Request by Jim Luckey, President of the City of Franklin Historical Society, to place a memorial bench (in memory of Eldred and Julie Swanson) in the Franklin historic village, located at 8120 South Lovers Lane Road (within Lions Legend Park).

Request by Douglas Scherrer, on behalf of Franklin Park Concerts, Inc., for the use of Lions Legend Park band shell for a free summer concert series, from 12:00 p.m. to 4:30 p.m., on the following dates: June 26, 2022, July 10, 2022, July 25, 2022, August 7, 2022 and August 21, 2022.

Commissioners made recommendations for inclusion of an ice-skating rink. Possible locations at Pleasant View or Lions Legend for a portable ice-skating rink. Options are EZ Ice and Nice Rink. Looking for biggest rink with bumpers

Fund needs, Street Improvement Fund needs and Major Capital Expenditures to be made with borrowed funds. Park amenities including ice skating rink. (approximately 40' x 80'), with a \$6,000 budget. Chair Wrench suggested volunteers help with flooding and shoveling to relieve the burden of DPW.

Alderwoman Hanneman moved and Vice Chair Bartels seconded a motion to recommend to Common Council adding the purchase of an ice-skating rink to the budget. On voice vote, all voted 'aye'. Motion carried (6-0-0).

In 2021 the Parks Commission recommended amenities, facilities, and other items for inclusion in the Five Year Capital Improvement Program for the City. Budget items may fall into several categories. Broadly, these are the purchase of new parks, facilities, and amenities (capital expenses) which qualify for Park Impact Fees; capital items which do not qualify for impact fees; maintenance of existing facilities; and equipment and personnel.

City Administrator Steeno has provided a copy of the Five Year Capital Improvement Program for 2022-2026, attached for your review. Park items are listed under "DPW-Parks" for each year. Items that qualify for impact fees are indicated in the column "funding sources." Information in this plan pertains to several items on the March 14, 2022 Commission agenda:

Items No. IV.E Budget Overview & Ice Skating Rink

A portable Ice Rink was included among the Commission's requests for Capital program, and was added to the 2022 capital budget.

Items No. IV.G Southwest Park

At the September 21, 2021 meeting of the Common Council, the City adopted the Parkland Acquisition Study, and recommended Scenario E for the future use of Impact Fees (Item G.4). Scenario E recommends the purchase of a large "Community Park" as defined by the Comprehensive Outdoor Recreation Plan. The approximate recommended size under the funding calculus was 60 acres. Scenario E also includes a recommendation of land acquisition and

I would be happy to assist, but I am not aware of any open spaces that would accommodate a cricket field. Google tells me:

There are no specific dimensions required by the laws of the game so the exact circumference of the field will differ from ground to ground. In general, the diameter of a cricket field will vary between 450 feet and 500 feet (137 metres and 150 metres). On its perimeter, a boundary will be clearly marked.

Until we start to develop the SW park, or another location, I don't believe that we have an adequate location. We are in the process of developing Pleasant View for other uses and the adjacent areas are off limits for such a development.

Glad it is on the agenda, Staff needs guidance/recommendation from the Commission. You might ask the Cricket group to be proactive and suggest an adequate location.

Dear Mr. Chairman,

I am a resident owner at MacKenzie Square Condominiums, which borders Ernie Lake Park. My wife and I have lived at MacKenzie Square since 1998. Our condo is alongside the north end of the Ernie Lake Park walking path. Two years ago, we installed several birdhouses on our property with the goal of increasing the small bird population in the neighborhood. We also feed the birds with several feeders. In 2021, I built two birdhouses and installed them in trees in Ernie Lake Park along the across from the lake.

The bird houses I have built are 9" x 5 $\frac{1}{2}$ ". They are of sturdy construction and should last several years. Each birdhouse I have custom painted with beautiful bird/nature scenes over a pastel (off white, or blue) base coat. The boxes are hinged for cleaning. I cleaned out each one at the end of 2021. Almost every birdhouse I installed in the park or on private property along the walking path was utilized by house wrens, chickadees, finches or sparrows. The boxes are hung using wire only with no damaging nails used.

The birdhouses were a hit! My wife and I spent the entire summer of 2021 sitting on the deck listening to adults, and especially the youngsters, walk by with laughter and smiles counting and admiringly commenting on the "beautiful" birdhouses. Many passersby take pictures. I have received many positive comments from neighbors at MacKenzie Square, and the Mission Hills Apartments.

Last week, I found the two birdhouses that had been installed in the park, removed and placed under another box on our property. I assume the city removed them. If they were removed because permission to install them was not made, I understand that, and apologize for not doing so. I did not assume it would be an issue. I cannot imagine another reason for their removal. I had in fact, built additional birdhouses and planned to install more in the park this spring.

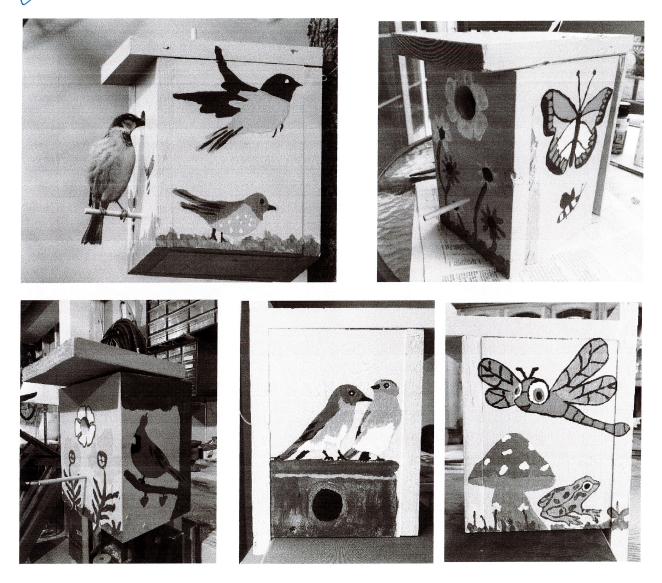
My hope is that I may receive permission to reinstall the removed and additional birdhouses this spring so the neighborhood may again enjoy them; and the bird population may as well. There is no cost or burden to the City. As information, with the help of Alderman Dan Mayer, I previously installed the wood duck nesting box in Ernie Lake. I also found, rehabilitated, then
