# Speaker Paul Ryan answers questions at Franklin business

House Speaker Paul Ryan made several stops in his district Friday to hold employee town halls, answering questions on Foxconn, tax reform and improving the education system in America.

Friday afternoon, he visited Allis Roller in Franklin where he received a brief tour before addressing the employees. He praised the company for recently hiring 25 new employees.

### Bill Allows Foxconn To Skirt Environmental Regulations

But he said the country's tax code needs reforming so more companies can follow suit.

"We have a really bad tax system and our tax system right now penalizes American businesses in a way that our foreign competitors don't," Ryan said.

He followed up on the issue after the town hall, when asked his thoughts on Senate Democrats saying tax reform should not benefit the wealthiest individuals.

"Tax reform will pay for itself but what I think people are missing when they use this rhetoric, take a look at this business right here, this is an LLC. So as far as people are concerned, this

But Ryan's main reason for visiting this company was to highlight a program called GPS Education Partners that employs high school students, so they can learn manufacturing skills while earning credit for school.

"We have to get back to the notion that a two-year school is cool, I mean it really is," Ryan said.

"You can learn great skills, great trades, have a good career, make a really good living and you
don't have to go to a four-year school and load up on a bunch of debt and spend years working
it off."

Foxconn also came up at the town hall. One employee asked why the state is giving Foxconn \$3 billion in incentives to come here, when other businesses already here are struggling to stay afloat.

Ryan answered the question by saying the incentive package is misunderstood and it's conditional based on if Foxconn delivers on its promises to bring at least 3,000 jobs.

He also said Foxconn would not have chosen Wisconsin without these incentives.

"This one deal is worth the reach, it's worth the stretch because what it does is it makes Wisconsin the industrial park for Silicon Valley which means we're going to have a very vibrant manufacturing sector in Wisconsin for a long time coming," he said.

In 1920, Prohibition halted beer production and the need for a new direction arose. "It's rare to see a company persevere to commemorate such an achievement," notes GHN President Brian Sternberg. "Especially one who has endured the adversity we faced early on. We could have given up when Prohibition began, but that's not the GHN spirit."

Instead, then Galland Henning made a strategic decision to diversify, transforming their cylinder-based manufacturing capability to focus on a growing need for scrap metal balers, the product the company is best known for today. Innovation paid off.

"When Prohibition was repealed, malt beer companies came running to us for new versions of our trusted malting products," Sternberg explains. "But the excitement around our triple compression presses never dimmed. Our balers could swallow whole auto bodies and neatly compact them into the uniform blocks required for manually-operated control valves. We'd resumed one successful business and grown into a trusted partner for a second."

In the decades that followed, Galland Henning created another industry innovation with its launch of the Nopak line of air control valves and double-acting cylinders, eventually changing its name to Galland Henning Nopak. The firm was also instrumental in establishing the National Fluid Power Association in its hometown of Milwaukee.

FRANKLIN – Lt. Governor Rebecca Kleefisch joined Department of Workforce Development (DWD) Secretary Ray Allen, German American Chamber of Commerce of the Midwest (GACC Midwest) officials and other partners today to recognize the Hermle Machine Company for being the first employer in the state to introduce a new apprenticeship collaboration that follows the structure of internationally renowned German apprenticeship system.

"With the state's unemployment rate at 3.2 percent, Wisconsin's job creators need a robust set of tools to attract and train workers to stay competitive in the national and global economy," Lt. Governor Kleefisch said. "Today, Wisconsin welcomes a proven, successful collaboration between the private sector, the state's apprenticeship program, and the German American Chamber of Commerce of the Midwest, and we thank the Hermle Machine Company for its enthusiasm in advancing this opportunity in our state."

Wisconsin DWD's Registered Apprenticeship program, which was created in 1911 and has served as a national model for generations, provides a value-added training model for as many as 11,000 apprentices and 2,500 employers in over 200 occupations across the state annually.

GACC Midwest established the Industry Consortium for Advanced Technical Training (ICATT) program in 2015 based on the structure of the internationally renowned German Dual Education System. The Chicago-based GACC Midwest has been expanding the program in and beyond Illinois, and this year worked with officials from DWD, the Wisconsin Economic Development Corporation (WEDC), the Wisconsin Technical College System and other partners to bring the program to Wisconsin. The ICATT program will be another program available under the state's Registered Apprenticeship system.

The structure of the three-year program will allow apprentices to register with the state, complete on-the-job training and earn an associate's degree, with GACC Midwest providing expertise and certification along the away. The first ICATT apprenticeship in Wisconsin will focus on industrial maintenance.

"At Hermle we understand how important building the next generation of skilled workers is, and it's why we put so much effort into our apprenticeship program in Germany," said Manuel Merkt, Hermle's Executive Vice President of Operations. "The jobs are here, but It's up to manufacturing companies together with technical colleges to develop younger generations into skilled workers to meet the demands of the industry. With the ICATT program we're looking to inspire other companies to join us and invest in the future of manufacturing in America."

Mario Kratsch, Skills Initiative Director at GACC Midwest, said, "Apprenticeships work, not just in Germany, but also in the US. ICATT is a one stop shop solution for companies of every size to join. It is an industry-driven program benchmarked to the highest international standards and directly addresses the

challenges companies face today. We are very thankful for the State of Wisconsin's support in promoting ICATT to contribute positively to company and job growth in Wisconsin."

During a visit today to Hermle, Lt. Governor Kleefisch presented the company with a commendation for its partnership to bring ICATT to Wisconsin, and recognized GACC Midwest for its vision and innovation in developing the program. Today's event is part of Workforce Development Month, which Governor Walker proclaimed for the month of September.

Baptista's Bakery (https://baptistas.com/) is planning to add 125 jobs to its workforce in Franklin over the next three years as part of a \$7.8 million investment in its facilities.


The company, which makes pretzel crackers and dippable tortilla chips, was acquired by North Carolina-based Snyder's-Lance Inc. in 2014.

Baptista's currently has around 400 employees at the facility, which plays a vital role in the production of innovative snacks for Snyder's-Lance.

The expansion project includes building renovations and investments in machinery and equipment. It is being supported by \$300,000 in state income tax credits from the Wisconsin Economic Development Corp.

"The company has experienced tremendous growth over the last five years and has already doubled employment at its Franklin facility," said Mark Hogan, WEDC secretary and chief executive officer. "Baptista's has already invested more than \$100 million in its facility, and we are pleased to assist the company in the next phase of its growth."

The company currently has 11 job openings for its Franklin facility posted on its website. A company spokesman could not immediately provide additional details on the positions the company plans to add.
