Voting By Absentee Ballot
Fall Partisan Primary Election on August 11, 2026

Any qualified elector who is unable or unwilling to appear at the polling place on Election Day may request to vote an absentee ballot. A qualified elector is any U.S. citizen who will be 18 years of age or older on Election Day, and who has resided in the ward or municipality where he or she wishes to vote for at least 28 consecutive days before the election. The elector must also be registered in order to receive an absentee ballot. Proof of identification must be provided before an absentee ballot may be issued.

Making application to receive an absentee ballot by mail.

Contact your municipal clerk and request that an application for an absentee ballot be sent to you for the Election. You may also submit a written request in the form of a letter. Your written request must list your voting address within the municipality where you wish to vote, the address where the absentee ballot should be sent, if different, and your signature. You may make application for an absentee ballot by mail, by fax, by email, at myvote.wi.gov or in person. The deadline for making application to receive an absentee ballot by mail is 5:00 p.m. on August 6, 2026, the fifth day before the election.

Voters who are indefinitely confined due to age, illness, infirmity, or disability may not be required to provide photo ID. If this applies to you, contact the municipal clerk regarding deadlines for requesting and submitting an absentee ballot. Special absentee voting application provisions apply to electors who are indefinitely confined, in the military, hospitalized, or serving as a sequestered juror. If this applies to you, contact the municipal clerk regarding deadlines for requesting and submitting an absentee ballot.

Voting an absentee ballot in person

You may also request and vote an absentee ballot in the clerk's office or other specified location during the days and hours specified for casting an absentee ballot in person.

Cudahy residents should call the City Clerk's office at 414-769-2204 or appear at Cudahy City Hall, 5050 S. Lake Dr., Cudahy WI, on weekdays between the hours of 7:30 a.m. and 4:30 p.m., and between the hours of 7:30 a.m. and 5:00 p.m. on Friday, August 7, 2026.

Franklin residents should call the City Clerk's office at 414-425-7500 or appear at Franklin City Hall, 9229 W. Loomis Rd., Franklin WI, on weekdays between the hours of 8:30 a.m. and 4:00 p.m. and between the hours of 8:30 a.m. and 5:00 p.m. on Friday, August 7, 2026.

St. Francis residents should call the Clerk's office at 414-481-2300 or appear at St. Francis City Hall, 3400 E. Howard Ave., St. Francis WI on weekdays between the hours of 8:00 a.m. and 5:00 p.m.

South Milwaukee residents should call the Clerk's office at 414-762-2222 or appear at South Milwaukee City Hall, 2424 15th Avenue, South Milwaukee, WI on weekdays between the hours of 7:45 a.m. and 4:00 p.m., between the hours of 8:00 a.m. and 6:00 p.m. on August 6, and between the hours of 8:00 a.m. and 5:00 p.m. on August 7, 2026.

The first day to vote an absentee ballot in the clerk's office is Tuesday, July 28, 2026, which is 14 days before the election. The last day to vote an absentee ballot in the clerk's office is Friday, August 7, 2026, which is the Friday before the election. No in-person absentee voting may occur on the day before the election.

The municipal clerk will deliver voted ballots returned on or before Election Day to the proper polling place or counting location before the polls close on Tuesday, August 11, 2026. Any ballots received after the polls close will not be counted.
