## **ORDINANCE NO. 2025-2703**

AN ORDINANCE TO AMEND ORDINANCE 2024-2649, AN ORDINANCE ADOPTING THE 2025 ANNUAL BUDGETS FOR THE FIRE DEPARTMENT GRANTS FUND TO PROVIDE ADDITIONAL APPROPRIATIONS TO SUPPORT THE NECESSARY EQUIPMENT REPAIRS NEEDED FOR THE FIRE DEPARTMENT

WHEREAS, the Common Council of the City of Franklin adopted the 2025 Annual Budgets for the City of Franklin on November 19, 2024; and

WHEREAS, the Franklin Fire Department MED 113 suffered a catastrophic engine failure on September 10, 2025 while returning from a patient transport; and

WHEREAS, it is critical to repair MED 113 due to the limited availability of reserve ambulances; and

WHEREAS, the City of Franklin receives grant resources annually from the State of Wisconsin (FAP Act 102 Grant) which provides supplemental aid for support and improvements to EMS systems; and

WHEREAS, this grant funding may be used for specific EMS equipment, training projects, ambulance vehicle purchases, and EMS vehicle repairs/equipment; and

WHEREAS, the City of Franklin has adequate reserves from the Act 102 Grant fund to provide appropriations for this repair; and

WHEREAS, budget appropriations are needed to support the expenditures related to the program; and

WHEREAS, the Budget Appropriation Units should be adjusted for the above items as listed below.

NOW, THEREFORE, the Common Council of the City of Franklin does hereby ordain as follows:

Section 1 That the 2025 Fire Department Grant Fund Budget be amended as follows:
