
## CITY OF FRANKLIN


The solid waste collection charge increases \$20.00 over 2022, 2023 rate at \$159.60.

The 2023 general property tax levy is used to fund government operations in the 2024 Budget. The City of Franklin continues to experience some of the lowest tax rates in Milwaukee County. Franklin's property tax levy which covers total City spending has grown very slowly over the last 10 years compared to most other taxing authorities.
