
CITY OF FRANKLIN

The City of Franklin completed a revaluation in 2021, which raised residential assessments approximately 8.6% over 2020.

The solid waste collection charge increased from \$134.60 to \$139.60.



The 2021 property tax levy is used to fund government operations in the 2022 Budget. The City of Franklin continues to experience some of the lowest tax rates in Milwaukee County. Franklin's property tax levy which covers total City spending has grown very slowly over the last 10 years compared to other taxing authorities.
