
CITY OF FRANKLIN

The City of Franklin completed a revaluation in 2022, which raised residential assessments approximately 10.2% over 2021. The solid waste collection charge remains the same as 2021, at \$139.60.

Please direct any concern relative to an increase in property tax levy by a taxing jurisdiction to that respective tax jurisdiction.



The 2022 general property tax levy is used to fund government operations in the 2023 Budget. The City of Franklin continues to experience some of the lowest tax rates in Milwaukee County. Franklin's property tax levy which covers total City spending has grown very slowly over the last 10 years compared to most other taxing authorities.
