


The 2020 property tax levy is used to fund government operations in the 2021 Budget. The City of Franklin continues to experience some of the lowest tax rates in Milwaukee County. More importantly, Franklin's property tax levy which covers total City spending has grown very slowly over the last 10 years compared to other taxing authorities.

Although Franklin's tax rate is lower than the vast majority of its neighboring communities, the higher property values results in higher tax bills.

Your tax bill reflects changes in the property tax rates and change in the property assessment.

The City of Franklin had a revaluation in 2020, which raised residential assessments approximately 6.0% over 2019.

The solid waste collection charge is unchanged at \$134.60.
