I. The October 1, 2020 Finance Committee Meeting was called to order at 5:18 p.m. in the Common Council Chambers of Franklin City Hall by Chair Ciche.

- III. Review of the 2021 Mayor's Recommended Budget Related to TIF Districts, Debt Service, Self-Insurance Fund, and Tax Levy/Rates

Director of Finance & Treasurer Paul Rotzenberg and Director of Administration Peggy Steeno presented and reviewed this item with the Committee.

(Alderman Nelson left the room at 6:51 p.m. and returned at 7 p.m. The Committee took a break at 6:55 p.m. and resumed at 7 p.m.)

Motion made by Alderwoman Hanneman and seconded by Alderman Nelson to add \$75,000 of Shared Revenue to the General Fund, remove \$75,000 of Landfill Siting Revenue from the General Fund, add \$23,500 of Landfill Siting Revenue to the Capital Outlay Fund, and add \$51,500 of Landfill Siting Revenue to the Capital Improvement Fund. Upon vote, Ayes-All, Motion carried.

Motion made by Alderman Nelson and seconded by Member Howard to add \$241,900 of General Transportation and Resources to the Street Improvement Fund. Upon vote, Ayes-All, Motion carried.

Motion made by Alderwoman Hanneman and seconded by Alderman Nelson to add \$20,000 to the Capital Improvement Fund as appropriation for the DPW Building Expansion Project. Upon vote, Ayes-All, Motion carried.

Motion made by Alderwoman Hanneman and seconded by Member Howard to add \$3,027,399 as resources to the Self-Insurance Fund and \$3,082,782 as appropriations in the Self-Insurance Fund as presented by staff. Upon vote, Ayes-All, Motion carried.
