1. COVID Referral Updates

b) Franklin Trending Data Franklin's Burden Rate has flattened, possibly

due to less people being tested.

c) Testing Updates There is a drive-up testing site in Franklin at

Summit Labs around 76th and Rawson Ave.

d) Vaccine Updates The Health Department received no vaccine this

week, unknown why the State did not send any. Currently the Milwaukee County Suburbs are receiving only about 22% of the vaccine they are requesting. Clinics are still taking place, with

vaccine from the previous week.

1. Human Service Referrals The Health Department continues working on

welfare check referrals.

2. Upcoming Senior Programming The Health Department is working on starting

up Senior programming again. Stepping On Workshop will start in Spring with a smaller number of people in a larger room than normal. There are also some Speaker Programs in the

works with virtual options available.
