II. Approval of the Minutes of the April 8, 2021, June 10, 2021, and July 6, 2021 Meetings.

IV. Hiring of Police Patrol Officer-The Hiring of Bradley S. Treiber as a City of Franklin Police Department Patrol Officer from the September 2020 Police Patrol Hiring Process-Existing Officers.

Motion by Commissioner Mineo and seconded by Commissioner Martins to add the name of Bradley Treiber to the existing eligibility list for the September 2020 Hiring Process. Motion Carried: Ayes – All.

Motion By Commissioner Schnagl and seconded by Commissioner Lenz that Bradley S. Treiber is hereby appointed to the position of City of Franklin Police Patrol Officer effective as of a date to be decided by the Police Chief, contingent of approval by the Commission President after completion of pre-employment testing, that said appointment is subject to a 1-year introductory period commencing on the effective date of his appointment, that the 1 year introductory period will expire at the end of 1 year unless extended by the Commission, and the Police Chief shall provide the Commission reports of his progress when requested by the Commission.
