## C. NEW BUSINESS

1. HARBOR HOMES 11498 WEST MEADOWVIEW DRIVE CONTRACTOR: HARBOR HOMES NEW SINGLE-FAMILY DWELLING

Mr. Heinritz moved to approve the plans for a New Single-Family Dwelling as submitted, with the addition of a 48" wide transom or hopper style window in the garage left view and a window in the flex room to match the size and style the 2<sup>nd</sup> story windows, subject to meeting the requirements of the Building Code. Seconded by Mr. Cyra. On roll call all voted Aye; motion carried.

2. STEPPING STONE HOMES 9562 SOUTH BERGAMONT DRIVE CONTRACTOR: STEPPING STONE HOMES NEW SINGLE-FAMILY DWELLING

Mr. Heinritz moved to approve the plans for a New Single-Family Dwelling as submitted, with the addition of the front elevation window detail on the rear elevation to include the divided lite (two or four divided lites) on the double hung sashes with matching trim detail from the front elevation to the rear window detail, subject to meeting the requirements of the Building Code. Seconded by Ms. Chu. On roll call all voted Aye; motion carried.

3. STEPPING STONE HOMES 9761 SOUTH BERGAMONT DRIVE CONTRACTOR: STEPPING STONE HOMES NEW SINGLE-FAMILY DWELLING

Ms. Chu moved to approve the plans for a New Single-Family Dwelling as submitted, subject to meeting the requirements of the Building Code. Seconded by Mr. Cyra. On roll call all voted Aye; motion carried.

4. VERIDIAN HOMES LLC 7427 SOUTH 49<sup>TH</sup> STREET CONTRACTOR: VERIDIAN HOMES LLC NEW SINGLE-FAMILY DWELLING

Mr. Heinritz moved to approve the plans for a New Single-Family Dwelling as submitted, with the addition of a gable vent on the higher points of the right and left elevations, subject to meeting the requirements of the Building Code. Seconded by Mr. Cyra. On roll call all voted Aye; motion carried.

5. VERIDIAN HOMES LLC 7365 SOUTH 50th STREET CONTRACTOR: VERIDIAN HOMES LLC NEW SINGLE-FAMILY DWELLING

Ms. Chu moved to approve the plans for a New Single-Family Dwelling as submitted, with the addition of a gable vent on the right and left elevation, subject to meeting the requirements of the Building Code. Seconded by Mr. Nierode. On roll call all voted Aye; motion carried.

6. VERIDIAN HOMES LLC 5052 WEST MARQUETTER AVENUE CONTRACTOR: VERIDIAN HOMES LLC NEW SINGLE-FAMILY DWELLING

Mr. Heinritz moved to approve the plans for a New Single-Family Dwelling as submitted, with either altering the left elevation to have matching window grids on all double hung windows or removal of window grids of all double hung windows on the left elevation, subject to meeting the requirements of the Building Code. Seconded by Mr. Nierode. On roll call all voted Aye; motion carried.
