- V. Hiring of Police Patrol Officer The Hiring of Derek Zehetner as a City of Franklin Police Patrol Officer from the 2021 Police Patrol Officer Hiring Process Existing Officers.
  - Motion by Commissioner Donohoo and seconded by Commissioner Martins that Derek Zehetner is hereby appointed to the position of City of Franklin Police Patrol Officer effective 10/9/23, that said appointment is subject to a 1 year introductory period commencing on the effective date of hire, that the 1 year introductory period will expire at the end of 1 year unless extended by the Commission, and the Police Chief shall provide the Commission reports of his progress when requested by the Commission.
