- I. The Franklin Economic Development Commission (EDC) meeting was called to order at 2:30 p.m. by Vice Chairman Timothy Wachter.
- II. The floor was opened for Citizen Comment at 2:31 p.m. No citizens were present, and Citizen Comment closed at 2:32 p.m.
- III. Approve Minutes from the July 17, 2025 Meeting – Motion by Barber, second by Eichmann, to approve. Motion Carried.
- IV. Strategic Planning Report and Implementation Plan Editing – Vice Chairman Wachter initiated the review and editing of the Draft, which was conducted on a projected version. The Commission focusing on pages 12 through 17 being mindful of available resources and updating deadlines.
