- **b.** Treasurer's Report The June report represents 49.59% of the year. Fund 15 total revenue is 96.714% of the budget. Total expenditures are 45.89% of the budget. Fund 16 total revenue is 52.26% of the budget. Total expenditures are 41.15% of the budget. Cash register was perfect as expected.
