MINUTES

I. The April 6, 2010 Police & Fire Commission Meeting was called to order at 1:00 p.m. by Commission President Donohoo in the Inspection Conference Room at Franklin City Hall.

Motion by Commissioner Omernik and seconded by Commissioner Sass to pass on the following people in the hiring process pursuant to our written hiring policy: 4, 5, 8, 9, 11, 12, 13, 14, 15, 17, 19, 20, 23, and 25. Numbers 22 and 24 are not passed on because they did not show for their interviews. Numbers 1, 2, 3, 6, 10, 16, 18, 21, and 26 are not passed on for further consideration. Commissioner Donohoo also stated that all votes on the candidates were unanimous.
