Review and recommendation to the Plan Commission regarding the design of a pavilion for Pleasant View Neighborhood Park located at 4620 West Evergreen Street. This item was presented to the Common Council at the City of Franklin, April 2, 2018 Common Council meeting. Motion as follows: Alderwoman Wilhelm moved to direct staff to pursue the design of an enclosed 2,400 square foot pavilion versus 3,000 square foot pavilion for Pleasant View Neighborhood Park as previously sized and presented to the public within the last four City budgets, the Comprehensive Outdoor Recreation Plan, and the previous two Impact Needs Assessments, all which were adopted after noticed public

On voice vote all voted 'aye.' Motion carried (5-0-2)

Alderman Nelson moved and Commissioner Johnson seconded a motion to recommend to the Common council at its next meeting, to place on the agenda for action, moving forward with the necessary steps related to budgeted but pending park land acquisition, which will allow a timely and appropriate use of Impact Fees to address existing land purchase deficiencies indentified in the CORP, and as previously requested by the Parks Commission. On voice vote, all voted 'aye'. Motion carried (5-0-2).
