- I. The August 28, 2013 Police & Fire Commission Meeting was called to order at 4:30 p.m. by Commission President Donohoo in the Hearing Room at Franklin City Hall. Fire Chief Remington, Assistant Fire Chief Mayer, Battalion Chief Hays and Human Resources Coordinator Zahn were also in attendance.
  
- II. Approval of the Minutes from July 15, 2013.  
  
Motion by Commissioner Sass and seconded by Commissioner Lindner to approve the minutes with agreement to change the word “appoint” to “elect”. Motion Carried: Ayes – All.
  
- III. Hiring of Firefighter/EMT - The hiring of Jonathan D. Perrino. The Police and Fire Commission may enter into closed session pursuant to sec. 19.85(1)(c) to consider the employment of Jonathan D. Perrino as a City of Franklin Firefighter/EMT. Said appointment is subject to a 1 year introductory period, commencing on the effective date of his appointment. The 1 year introductory period will expire at the end of 1 year unless extended by the Commission and finally that the Fire Chief shall provide the Commission reports of his progress as required by the Commission.
