WINTER SIDEWALK POLICY EXCEPTION(S) OAKWOOD ROAD FROM 27TH STREET TO WEST OF S. 34TH STREET	Motion made by Commissioner Wolff, seconded by Commissioner Rogowski to send to Common Council with BPW approval an ordinance to amend the municipal code to provide an exemption from public sidewalk snow removal requirement for owners of single-family residential dwellings abutting public sidewalks where the density of the dwelling structures is more than 750 feet apart as measured lineally along the property frontage abutting the public sidewalk. Motion carried.
CONSIDER ADDING A BYPASS LANE AT W. RAWSON AVENUE AND S. WOELFEL ROAD	Motion made by Commissioner Wolff, seconded by Commissioner Webster to direct staff to send request to Milwaukee County to construct a bypass lane at W. Rawson Avenue and S. Woelfel Road. Motion carried.
