Senior citizen parks.	Α.	Alderman Solomon updated the Parks Commission regarding the February 7, 2012 request to Common Council for support of an amendment to the Comprehensive Outdoor Recreation Plan: 2025 to include outdoor recreational facilities for senior citizens at City parks in areas of the City with concentrated populations of senior citizens. No action needed, none taken.
Friends of Franklin Parks - Update	В.	Commissioner Dorsan presented the Friends of Franklin Parks update and indicated that volunteers would be needed to clean out birdhouses this spring. No action needed, none taken.
Franklin Trails Committee - Update	C.	Alderman Solomon reported on the recent efforts of the Franklin Trails Committee to create a Complete Streets and Connectivity Advisory Board as a sub-committee. No action needed, none taken.
Parks Maintenance Report	D.	Superintendent of Public Works Schaefer presented the Parks Maintenance report and indicated that plans are underway to repaint 10 Park signs. He also suggested a double fee for rental of the Ken Windl Park Pavilion during winter months should be considered due to the costs associated with potential snow plowing and sidewalk clearing. As requested at the January 16, 2012 Parks Committee meeting, Mr. Schaefer reported a rough estimate of \$5,000.00 to add a counter, sinks, and roll top doors to serve the picnic shelter area of the Lions Legend Park Pavilion. Commissioner Nickerson moved and Commissioner Dorsan seconded to authorize Superintendent of Public Works Schaefer to draw up plans for the counter and sink installation for the pavilion at Lions Legend Park. All voted 'aye', motion carried.
