- A. Commissioner Fowler moved and Commissioner Bennett seconded approval of the January 19, 2012 minutes of the regular meeting of the Plan Commission as amended at Item III.A. indicating Commissioner Fowler made the motion to approve. All voted 'aye', motion carried.
- A. Planning Manager Dietl presented the amendment application to the Master Sign Program for Wyndham Village Retail, LLC located at approximately 7700 to 7800 South Lovers Lane Road.
