| REPORT ON WATER SYSTEM PERFORMANCE | All antennas back on top of water tower. Staff working to get contractor (Horizon) back to complete finishing work on tower. Requested a time schedule. |

| RETIREMENT OF WELL HOUSES | Recommendation to abandon wells 5, 7, 8 & 10. Concern for annual maintenance, including increasing DNR testing and future station repairs. Wells are tested quarterly, rarely pumped into system. |
| | Motion made by Commissioner Bate seconded by Commissioner Schubilske to direct staff to begin investigation of abandonment plan of wells for Board review. Motion carried. |
| PROPOSED SEWER/WATER BUILDING | Finance Directors Rotzenberg & Patterson reported that financing is feasible from both a Sewer and Water standpoint. It was indicated that this may be a desirable time with financially low interest rates and a competitive bidding climate to construct now. Manager and Commission Chair to meet with the Mayor to start process & suggest visit current building with Aldermen. |
| | Motion made by Commissioner Schubilske seconded by Commissioner Bate to direct staff to begin discussions with Mayor about proposed sewer/water building. Motion carried. |
| FRANKLIN WATER UTILITY – PURCHASED WATER | Reviewed graph of purchased water over the last ten years. It was noted that a significant (25%) increase incurred from 2004 to 2005 as retail customers of Oak Creek in Franklin became customers of Franklin. Annual variations are weather dependent. Sprinkling can raises water consumption during third quarters. |
