Member Nickerson moved and Member Megna seconded to recommend approval to the Common Council of an expansion of a non-conforming use per Section 15-3.1010(E) of the Unified Development Ordinance for On The Border, an adult-oriented establishment, to allow for construction of a new access drive extending from West Elm Road to the northwest corner of the existing parking lot, construction of an approximately 1,500 square foot building addition to include a smoking area and storage room, and installation of a fence between On The Border's property and Reliable Truck Maintenance, location to be determined at time of Site Plan approval, accepting the Findings and Factors as presented by the applicant and subject to the applicant obtaining Site Plan approval from the City of Franklin Plan Commission and approval of a Certified Survey Map by the City of Franklin Common Council to combine the properties located at 10741 South 27 Street and 2825 West Elm Road, prior to issuance of a building permit.
