III. Approval of January 9, 2017 minutes

2. Update on 2017-2019 Governor Walker's DHS budget The Governor's report was provided to the Board to review.

VII. New Business

A. Assessment

1. Milw. Co. (SurvNet) and FHD Communicable Disease Reports

The SurvNet Report was reviewed and its purpose was discussed. The hospitalizations for influenza jumped to 307 and 9 mumps cases reported for the county. There were 6 flu hospitalizations reported to the City of Franklin Health Department most of which were elderly, there were also 5 reported dog bites and one social service referred by the Police Department for the month of February.

2. WI Public Health Respiratory Virus Surveillance Report

The vaccine for influenza was a match. This year's illnesses actually came later than last year. There was one pediatric death in Milwaukee County reported on March 8th. The best vaccinated population were the elderly 65+ population and the least vaccinated were the adults 18-45 years. Children were more likely vaccinated than their parents.

3. Hantavirus & Norway Rats Investigation in WI

There are individuals in the state of Illinois that are raising rats as pets. Some of the rats were infected with the Hantavirus which may be contracted through a bite, or the rat's excrement. State Department of Health Services is working with multiple health departments to assess the health of rats kept as pets. There have been three cases in Wisconsin.

4. Trends in Tobacco. CDC Winnable **Battle Indicators**

Tobacco use for adults in the US has gone down to 15% of the population. 60% of all businesses and workplaces are smoke free. The tobacco use among children has also been reduced to the targeted percentage.

5. Health Insurance Coverage in WI, WI DHS Findings (2015) Wisconsin has 5.6 million people; 91% of the people in Wisconsin (based on the random telephone survey) on average were fully insured for 2015. About 3% of the population were without insurance during the survey. The average age of the uninsured was between 18 and 41.

1. Common Council approves 5K Community Run/Walk supported by O.F.F.

The Board discussed the May 6' 2017 Operation Fit Franklin (O.F.F.) 5K Community Run/Walk initiative which was approved at the Common Council meeting of February 21, 2017.

C. Assurance

1. 2016 WI WINS Report The county report for illegal sales of tobacco to youth showed that there were 21 sales out of 174 attempts which is a 12% rate which is an improvement. The previous year was higher at 21%.

2. 2016 Medication & Sharps Disposal Report

There were 407 unduplicated individuals came to the Health Department with contaminated needles and lancets. There were about 1300 lbs. collected for 2016. The Police Department is also collecting prescription and over-the-counter medications in a drop box. The current contracted waste hauler for sharps is able to take more products without incurring additional costs.

3. 2017 Light & Unite RED Report

A summary of events that were held city and countywide were summarized in a report to promote awareness to substance abuse and treatment.

4. 2017 Tobacco Poster Contest-7th Grade Students

The guidelines for students to create their tobacco prevention movie poster were distributed and reviewed by the Board. 9 winners who will receive \$100 and their artwork/poster will be transferred to a professionally designed poster and displayed at the Showtime Theatre.
