Motion made by Alderman Dandrea and seconded by Member Howard to recommend to Common Council to direct staff to update all Impact Fees in a new study and to provide a Request for Proposal and assign staff to complete the information needed as inputs to the study, commissioning the study by Sept 1, 2018, and requiring the report be returned within nine months. Upon vote, Ayes-All, motion carried.

Motion made by Alderman Dandrea and seconded by Alderman Nelson to recommend to Common Council to immediately reduce the Park Impact Fee by 25% until such time as a new Park Impact Fee Study can be completed and acted upon by the Common Council. Upon vote, Aves-3; Noes-3, motion failed.
