Seconded by Commissioner Graef. On roll call, all voted Aye; motion carried.

NEW BUSINESS

AMENDMENT TO THE RAWSON HOMES WATER RELAY PROJECT:

Manager Morrow reported that earlier this year the bids for the Rawson Homes Water Relay project came in astronomically high and bids were rejected. We are going to rebid the project in October. Ruekert & Mielke needs to get a DNR permit and model the system which wasn't included in the original agreement.

Commissioner Peterson moved to approve the \$22,290 amendment to the Ruekert & Mielke agreement for the Rawson Homes Water Relay Project. Seconded by Commissioner Takerian. On roll call Commissioners Grobner, Peterson and Takerian voted Aye; Commissioner Graef voted No. Motion carried.

AUTHORIZATION TO SPEND \$17,800 FOR REPLACEMENT OF LARGE DIAMETER METERS WITH AUTOMATIC METER INTERGRATION TECHNOLOGY:

Superintendent Roberts indicated that our meter reading system is obsolete. It works but if it ever goes down, we will pay a premium price. This will get the Utility started with all the technology needed for the future with integration to cell/phone. We would start out with 15-17 of the highest users in the Business Park and build from there. This is the future that everyone is going to.

Commissioner Takerian moved to approve to spend \$17,800 for replacement of large diameter meters with automatic meter integration technology. Seconded by Commissioner Graef. On roll call, all voted Aye. Motion carried.

Commissioner Takerian moved to adjourn the meeting at 5:48 p.m. Seconded by Commissioner Peterson. All voted Aye; motion carried.
