## **04/01/2024**

### **Warrant Arrest S 27th St/S Riverwood Blvd**

On Monday, 04/01/24, at 0004 hours, a subject out of Milwaukee was taken into custody on a warrant with the Department of Corrections for Disorderly Conduct and Criminal Damage to Property and a warrant with the Milwaukee County Sheriff's Office for Retail Theft.
