

CITY OF FRANKLIN

04/07/2025

Retail Theft, Battery to Law Enforcement, Resisting Arrest 6701 S 27th St - Walmart

On Monday, 04/07/25, at 1150 hours, a subject out of Milwaukee was taken into custody for Retail Theft, Battery to Law Enforcement Officer, and Resisting Arrest. This occurred after he consumed merchandise inside the store and refused to pay for it. He then kicked a responding officer in the face while they attempted to take him into custody. He was booked, cited, and transported to County Jail. Charges were referred to the District Attorney's office for review.

On Monday, 04/07/25, at 1914 hours, officers located a vehicle reported as stolen through the Wauwatosa Police Department. The vehicle was towed from the scene. The driver of the vehicle was located and taken into custody. He was later turned over to Wauwatosa PD.

On Monday, 04/07/25, a resident reported discovering several purchases were made to her credit card. This occurred after she provided her credit card number to a subject who had contacted her claiming to be from Apple Support.

He later provided an evidentiary blood sample, the results of which are not yet known. He was booked, cited, and turned over to County Jail.
