The Milwaukee County Criminal Justice Facility is currently only accepting Felony and Domestic Violence offenders due to the ongoing health emergency. The House of Corrections currently will not accept prisoners held on municipal warrants.

08/28/2023

Fraud 6705 S 27th St – Sam’s Club

On Monday, 08/28/23, a victim reported her wallet was stolen from a location in Greenfield and that an unknown person(s) used her credit cards to make several unauthorized purchases at Sam’s Club and Walmart in our city.

Operating After Revocation – Misdemeanor

On Thursday, 08/31/23, a subject out of Cudahy was taken into custody for Operating After Revocation – OWI Related. He was booked, cited, and released with charges referred to the District Attorney's office for review.

He was booked, cited, and released after posting bail. Charges were referred to the District Attorney's office for review.

**Retail Theft, Possession of Drug Paraphernalia, Warrant Arrest

On Friday, 09/01/23, at approximately 1413 hours, a subject was taken into custody at South 27th Street and West College Avenue for Retail Theft and Possession of Drug Paraphernalia. This occurred after he left the store with unpaid merchandise valued at \$310.68.
