# Here is a list of notable events from the last week!

Some incidents may have been omitted to preserve the integrity of an ongoing investigation or to protect a victim. Incidents involving juveniles or calls related to a mental health crisis have also been omitted. Addresses are not specified in some cases, referred to instead by block.

## **08/04/2025**

**Trespassing, Possession of Controlled Substance/Drug Paraphernalia, Probation Violation**  
**6800 Blk S 112th St**

On Monday, 08/04/25, at 0202 hours, two subjects were taken into custody for Trespassing and Illegal Dumping. One of them was in possession of Narcotics/Paraphernalia and was booked, cited, and released. The other was in violation of her parole and was transported to the Milwaukee Secure Detention Facility. This occurred after they were found disposing of items in another person's dumpster without consent.

**Rescue**

On Sunday, 08/10/25, at 1625 hours, Franklin Police and Fire personnel responded to the 6500 block of West Drexel Avenue for the report of a person who had been swept away in the water. That subject was located approximately 50 yards south of W Drexel Ave and was rescued by FFD Dive Team personnel. They were later transported to an area hospital.
