


Weekly Roundup

12/22/2025

Operating a Motor Vehicle While Intoxicated – 1st Offense
10500 Blk W Cortez Cir

On Monday, 12/22/25, at 1356 hours, a resident of Milwaukee was taken into custody for Operating a Motor Vehicle While Intoxicated-1st Offense. This occurred after a witness reported him unconscious in his vehicle full of empty liquor bottles. He later provided an evidentiary breath sample which showed he had a Prohibited Blood Alcohol Concentration over 0.40. He was transported to an area medical facility for treatment and later turned over to a sober party.

Retail Theft

On Monday, 12/22/25, at 1836 hours, a resident of Milwaukee was taken into custody for Retail Theft. This occurred after he attempted to leave the store with unpaid merchandise valued at \$163.32. He was booked, cited, and released.

On Tuesday, 12/23/25, a resident reported being contacted by phone by a subject whom she has a Restraining Order against. Charges were referred to the District Attorney's office for review.

On Tuesday, 12/23/25, a resident reported being contacted by subjects claiming to represent Target who advised him that he had an outstanding balance on his Target credit card which needed to be resolved. He were instructed to provide the numbers to Apple gift cards in the amount of \$10,655.00 to resolve the matter. The resident did as he was instructed but later realized he had been scammed.

Warrant Arrest

On Thursday, 12/25/25, at 1636 hours, a resident of Burlington was taken into custody on a warrant with the Department of Corrections for 1st Degree Sexual Assault of a Child. This occurred after the DOC contacted FRPD and advised the subject was at the Plaza Motel based on the coordinates of her ankle monitoring bracelet. She was turned over to the Milwaukee Secure Detention Facility.

Battery

On Thursday, 12/25/25, at 2330 hours, officers responded to a residence for a physical altercation that had taken place there. It was determined both parties had engaged in the conflict during which a hammer had been used by one of the actors to harm the other. The other party had choked the actor with the hammer. Neither party wanted to be a complainant and no Domestic Violence criteria was met. Charges were sent to the District Attorney's office for further review.

Operating a Motor Vehicle While Intoxicated - 4th Offense

On Friday, 12/26/25, at 0645 hours, a resident of Franklin was taken into custody for Operating a Motor Vehicle While Intoxicated - 4th Offense. He later provided an evidentiary blood sample, the result of which are not yet known. He was booked and transported to County Jail.

On Friday, 12/26/25, at 0723 hours, an as-yet unidentified subject left the store with unpaid merchandise valued at \$145.47. He fled prior to officer arrival.

Trespass to Property, Possession of Controlled Substance/Paraphernalia, Prowling

Disorderly Conduct, Battery to Police Officer, Resisting Arrest 6715 S 27th St - Wendy's

On Saturday, 12/27/25, at 1535 hours, a resident of Milwaukee was taken into custody for Disorderly Conduct, Battery to Police Officer, Resisting Arrest, and Loitering. This occurred after employees reported the subject was loitering at the restaurant, giving sexually graphic handwritten notes to the female employees. As officers attempted to take him into custody, the subject resisted and fought with officers, causing bruising, a laceration, and a broken thumb to one of the officers. He was booked, cited, and transported to County Jail. Charges were referred to the DA's office.

Disorderly Conduct – Domestic Violence 9600 Blk W Loomis Rd

On Saturday, 12/27/25, at 2211 hours, a resident of Franklin was taken into custody for Disorderly Conduct - Domestic Violence Related. This occurred after he acted in a manner which caused his domestic partner to fear for her safety. He was booked and released after posting bail. Charges were referred to the District Attorney's office for review.

On Saturday, 12/27/25, a subject reported an as-yet unidentified subject created a disturbance at the store and called him a racial slur. She fled prior to officer arrival.

On Saturday, 12/27/25, South Milwaukee PD requested assistance in taking a Franklin resident into custody for offenses he committed in their jurisdiction. That subject resisted arrest and attempted to flee but was taken into custody and turned over to SMPD personnel.
