


Weekly Roundup

12/29/2025

Fire

8000 Blk S 27th St

On Monday, 12/19/25, at 0330 hours, Franklin Fire and Franklin PD responded to the report of a vehicle fire. Upon arrival it was observed to have spread to the attached garage of the residence. FFD was able to contain and extinguish the fire.

Warrant Arrest

On Monday, 12/29/25, at 1225 hours, a resident of Milwaukee was taken into custody on a warrant with the WI Department of Corrections for a parole violation. This occurred as the result of a request from the Department of Corrections for FRPD to attempt to make contact with him at his place of employment. The driver and occupants fled from the suspect vehicle on the 8700 Blk of W St Martins Rd. One passenger was taken into custody by OCPD in the area of S 80th/W Ryan, and the driver and second passenger were taken into custody during a K9 track with the assistance of a Muskego PD K9 and an OCPD drone.
