02/14/2022

Theft / Prowling 7300 Blk S 69th St

In the early morning hours of Monday, 02/14/22, FRPD responded to several calls reporting thefts from unlocked automobiles in the area of 68th St between W Rawson Ave and W Drexel Ave.

On Monday, 02/14/22, at 1654 hours, 2 as yet unidentified subjects removed \$219.98 in merchandise from Menards and fled before Officer arrival.

Eluding / Operate Motor Vehicle Without Consent 10741 S 27th St – On the Border

On Tuesday, 02/15/22, at 0044 hours, while responding to a Disorderly Conduct/Vandalism complaint at On the Border, Officers pursued a grey 2019 Chevrolet Equinox which fled the scene upon Police arrival. This vehicle was listed as stolen. The pursuit was terminated on W Drexel Ave at Drexel Town Square when officers lost sight of the vehicle. Investigation revealed the operator of the vehicle was involved in an altercation with a female in the parking lot of OTB. The female subject left the scene prior to officer's arrival. Follow-up to continue.

On Tuesday, 02/15/22, FRPD assisted the Milwaukee County Medical Examiner's Office with investigating the death of an 80 year old Franklin resident.

Fraud

Victim reported receiving a phone call from a subject identifying himself as JOHN from AT&T. The victim was instructed to log onto his computer through Ultra Viewer, which enabled the caller to gain access to his computer, to receive a refund for an overcharge. The caller was able to access the victim's bank information and fraudulently obtain \$600.00.

02/16/2022

Possession of Controlled Substance - THC
S 76th St/W Stonewood Dr

On Wednesday, 02/16/22, at 0623 hours, a resident of Franklin was taken into custody for Possession of Marijuana pursuant to the investigation of a traffic crash. The subject was booked, cited, and released.

A Franklin resident was found collapsed in her garage after Officers checked the residence at the request of a concerned third party who had not heard from her friend. The subject was transported by the Franklin Fire Department.
