01/10/2022

Retail Theft 7800 S Lovers Lane Rd - Target

On Monday, 01/10/22, at 1417 hours, at the Greendale DMV, a subject was taken into custody for Retail Theft and Possession of THC. This had occurred at the Franklin Target after the subject left the store with \$347.52 worth of merchandise without paying for it. He was found to be in possession of marijuana at the time of his arrest. After being booked and cited, the subject was released to the FRPD front lobby.

On Tuesday, 1/11/2022, at 1150 hours, Officers assisted the Milwaukee County Medical Examiner's Office in investigating the death of a 75 year old Franklin Resident.

On Wednesday, 01/12/22, at approximately 0143 hours, a Franklin resident was taken into custody for Battery – Domestic Violence. This occurred after the subject allegedly struck his wife, resulting in injuries. At approximately 0305 hours, after being booked and posting bail of \$500.00, the subject was released to the front lobby of the Police Department.

Retail Theft 6701 S 27th St - Walmart Supercenter

On Wednesday, 01/12/22, at 1126 hours, a subject out of Texas was taken into custody for Retail Theft after leaving the store with \$33.03 in merchandise without paying for it. After being booked, cited, and posting for his citation at the Franklin Municipal Court, the subject was released.

On Sunday, 01/16/22, at 0206 hours, at T-Mobile/ Sprint, unknown actor(s) had broken the glass of the front door of the business. Nothing was taken from the store.

Burglary 7017 S 27th St – T Mobile

On Sunday, 01/16/2022, at T-Mobile, 7017 S 27th St, between 0100 and 0215 hours, unknown actor(s) smashed out a side window at the business with a large rock and made entry into the store taking a cell phone and accessories. The total value of items taken and destroyed was approximately \$3,817.00.
